**Tender Notice**

**Subject: Extension of Auction notice (dated: 10/12/2021) for disposal of obsolete/unserviceable equipment/furniture etc, in light of Covid-19 restrictions imposed in the month of January, 2022.**

Tenders are invited for disposal of obsolete/unserviceable furniture/equipment/scarp etc. on 'As-Is-Where-Is' basis. A Notice Inviting Tender (NIT) of even number was published on 10/12/2021 and the bid period expired on 05/01/2022. However, due to the Covid-19 (Omicron) crisis in January, 2022, many interested bidders may have failed to apply for the bid. In view of the same, the competent authority has decided to extend the date for submission of the bids for a period of 15 days, effective the date of issue of this notice. **The bidders who have already made the bid during the previous bidding period need not apply for the same again as the same shall be taken into consideration. All the terms and conditions issued in the NIT previously shall remain the same.**


3. An EMD of Rs.5000/- (Rs. Five Thousand only) should be deposited with the tender in the form of Account payee/ Bank Draft/ Pay Order from any bank in favor of PAO (Sectt.), Ministry of Civil Aviation, payable at New Delhi.

General Terms and conditions:

- a. Bidders may inspect the items on dates and time stipulate above.
- b. The items shall be sold to the highest bidder. The bids are invited for the lot (i.e. all the items contained in the list of the obsolete/unserviceable furniture/equipment/ scarp as detailed in Annexure A) as a whole and no bid would be accepted for any part of the same.
- c. List of the items may be seen at Annexure A.
- d. The earnest Money Deposit (EMD) of successful bidder shall be adjusted from the total payment.
- e. The successful bidder has to make full balance payment after due adjustment of the EMD, in the form of a Demand Draft in the favor of PAO (Sectt.), Ministry of Civil Aviation, Payable at New Delhi within three days after confirmation, failing which the offer will be cancelled and the EMD shall be forfeit. The EMD of the unsuccessful bidders shall be returned within one month of the auction date, without any interest.
- f. No items once disposed shall be taken back by this department on any condition.
- g. The successful Bidder will be required to lift all the items from the disposal site within five days after the payment of the balance amount, On failure to do so this office reserves the right to forfeit the entire amount of the bidder and dispose of the items through the second highest bidder. The successful bidder at their own cost, shall also be required to arrange transport/manpower etc for transporting the scarp items.
- h. The bidders must have valid e-waste disposal certificates issued by CPCB or SPCB.
- i. No bids shall be accepted after the expiry of the period 05/01/22 (04:00 pm)
- j. The financial bids shall be clearly mentioned both in figures as well as words without any overwriting or erasing.



- k. The bidder must sign each and every page of the bid. The bidder is also required to furnish all the documents as mentioned in the technical and financial bids.
- l. Incomplete or unsigned tenders are liable to be rejected.
