The instant appeal bears Registration No. MOCAV/A/E/25/00018 and was filed on 27.06.2025.

2. The matter has been carefully examined along with the contents of the original RTI application and the reply furnished by the CPIO.
3. Upon perusal, it is observed that the information in the matter, as available with the CPIO at that point, was provided to you. The issue stated under RTI is under consideration of the Ministry and decision as per extant regulations shall be conveyed to the stakeholders.
4. It is a settled position under the RTI jurisprudence, and as reiterated in various decisions of the Central Information Commission, that the RTI mechanism is intended to provide existing information held by or under the control of a public authority and does not cast any obligation on the authority to generate or create information that is not available on record.
5. In view of the foregoing, the reply provided by the CPIO is found to be in consonance with the provisions of the RTI Act, 2005. Accordingly, no intervention is warranted by this Authority.
6. The appeal is hereby disposed of.
7. The appellant is, however, at liberty to prefer a second appeal before the Hon'ble Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi – 110067, within the period prescribed under Section 19(3) of the RTI Act, 2005, if he is not satisfied with the present decision.


