
Kindly refer to your application seeking information under RTI Act, 2005, vide Registration No. MOCAV/R/E/25/00349 received on transfer on 21.07.2025 for furnishing available information.

2. It is stated that Government of India (GoI) has formulated a Greenfield Airports (GFA) Policy, 2008 (available on the website of this Ministry at [www.civilaviation.gov.in](http://www.civilaviation.gov.in)) for development of Greenfield airports in the country. As per the policy, if any Airport developer including the State Government desires to develop an airport, they are required to identify a suitable site and get the Pre-feasibility Study conducted for construction of airport and submit a proposal to the Central Government for 'Site Clearance' followed by 'In-Principle' approval. In terms of GFA Policy, this Ministry has not received any proposal seeking site clearance for development of a Greenfield airport at Bhagalpur.

3. The copy of your application has also been transferred electronically to Airports Authority of India for furnishing available information, directly to you. Further, the application is also being transferred to PIO of State Government of Bihar for furnishing available information, if any.
