As per the policy, if any Airport developer including the State Government desires to develop an airport, they are required to identify a suitable site and get the Prefeasibility Study conducted for construction of airport and submit a proposal to the Central Government for 'Site Clearance' followed by 'In-Principle' approval. In terms of GFA Policy, this Ministry has not received any proposal seeking site clearance for development of a Greenfield airport at Bhagalpur.
