CAPEX would not include Capital grants, deposit works and special repairs expenditure and CAPEX of JV airports, if it is not capitalised (or classified as capital work in progress) in books of AAI.
- 3 If provision has been made, target/ achievement would be net of provisions.
- 4 If AAICLAS does not pay 30% of revenue from operations to AAI as concession in the year 2019-20, then above target will increase proportionately.

### Note :-

- Under-pitching of actual achievement for the year 2018-19; Pro-rata adjustment may be made in the targets in case of improvement in actual
  performance over the estimated performance in the base year.
- (ii) MoU negotiation and evalualtion would be done according to MoU Guidelines and clarifications issued by DPE from time to time.
- (iii) In working out achievements for the year 2019-20, quantified qualifications of CAG/Statutory Auditors would be adjusted in case of overstatement of Revenue / Profit/ Surplus or understatement of Loss/ Deficit in addition to the negative marks percribed in MoU guidelines.
- (iv) The targets decided are unconditional and no offset will be allowed on any ground. Further evaluation woruld be subject to compliance of Additional Eligibility criteria as contained in MoU guidelines.
