## Detailed Monthly information for the month of May, 2022

Important Policy decisions taken and major achievements during the month:

#### MINISTRY OF CIVIL AVIATION

A.

- The "Bharat Drone Festival, 2022" was organized from 27.05.2022 to 29.05.2022 which was inaugurated by Hon'ble Prime Minister and visited by a number of dignitaries and large number of public.
- 2. A delegation led by Hon'ble Minister of Civil Aviation visited International Civil Aviation Organisation (ICAO) headquarters, Montreal, Canada from 02.05.2022 to 04.05.2022. HMCA held discussions with President and Secretary General of ICAO, ICAO Council Members and representatives of some developed countries as well as like-minded developing countries. India's stand on issues such as Carbon Offsetting and Reduction Scheme For International Aviation (CORSIA) and Long Term Aspirational Goal For International Aviation (LTAG) were emphasized for bringing a just, inclusive and equitable policy on environmental issues in aviation sector.
- On 19.05.2022 a "Flag off Ceremony" was held for the first Air Export of food products from Assam to Vietnam from Guwahati Airport.
- Passengers carried by domestic airlines during January-April 2022 were 356.80 lakh as against 291.08 lakh during the corresponding period of previous year thereby registering annual growth of 22.58 % and monthly growth of 90.05 %.
- Under the Flexible Use of Airspace scheme, 119 conditional routes have been created by coordination between Airports Authority of India and Indian Air Force.
- Two new RCS routes commenced in the month of May, 2022.
- Seven hundred and forty two (742) Drones were registered and Unique Identification Number (UIN) were issued to them in the month of May, 2022.

#### TRAFFIC TREND:

Monthly Traffic Reporter for the month of April, 2022 has been prepared and uploaded on AAI website. The broad highlights of Traffic Reporter for the month of April, 2022 are as follows:-

**APRIL, 2022** 

During the month of April, 2022, all Indian airports taken together handled 198.22 thousand aircraft movements (excluding General Aviation Movements), 24.34 million passengers and 269.21 thousand tonnes of freight.

## A. Customer Satisfaction Survey

During May, 2022, Customer Satisfaction Survey at 07 AAI airports were conducted successfully.

B. Airports Council International – Airport Service Quality (ACI-ASQ) Survey

During May, 2022, ACI-ASQ survey at 13 AAI airports was conducted successfully.

## HOTEL CORPORATION OF INDIA LTD (HCI)

A. The performance of the Company in May 2022 has improved substantially with a Revenue of Rs 5.01 crore against Rs 1.48 crore in May 2021 i.e. an increase of 239% over the previous year.

## ALLIANCE AIR AVIATION LTD.

- A. As on 31.05.2022, Alliance Air is operating to 47 stations with 112 departures per day.
- B. Fleet Strength and On Time Performance- Alliance Air has a fleet of 18 ATR72-600 aircraft and 01 Dornier 228 and on time performance of 72.67% in May, 2022.
