

### Detailed Monthly information for the month of October, 2022

Important Policy decisions taken and major achievements during the month:

#### MINISTRY OF CIVIL AVIATION

1. The Foundation Stone for the manufacturing unit of Tata Advanced Systems Ltd. (TASL) for transport aircraft was laid by the Hon'ble Prime Minister on 30.10.2022 at Vadodara Airport. In this regard, Ministry of Civil Aviation supported TASL by providing 50 acre land on lease at Vadodara airport from AAI for a period of 6 years (extendable for further 6 months) or till TASL shifts to Dholera airport, whichever is earlier.
2. Foundation stone laid for construction of New Terminal Building of Rajmata Vijayaraje Scindia Terminal, **Gwalior Airport** by Shri Amit Shah, Hon'ble Union Minister of Home Affairs & Cooperation on 16.10.2022.
3. M/s Transhermes Aero IFSC Pvt. Ltd. has registered with International Financial Services Centers Authority (IFSCA) on 11.10.2022 for Aircraft Operating Lease. As on 31.10.2022, Eleven (11) Aircraft leasing entities have been registered with IFSCA.
4. Passengers carried by domestic airlines during Jan-September, 2022 were 874.24 lakhs as against 531.11 lakhs during the corresponding period of previous year thereby registering annual growth of 64.61% and monthly growth of
5. 10 new RCS routes commenced in the month of October, 2022.
6. 598 Drones were registered and Unique Identification Number (UIN) were issued for them in the month of October, 2022.
7. 350 Remote Pilot certificates were issued in the month of October, 2022.
8. A total number of 43224 files were reviewed and 32919 files were weeded out resulting in an approximate 42786 sq. feet of space freed in the office premises of the Ministry (Main Sectt.) and its organisations and generation of Rs. 2,49,27,308/- from the sale of scrap. Cleanliness campaigns at 134 sites in Ministry (Main Sectt.) and its organisations were conducted to ensure cleanliness as part of special *Swachhta* campaign.

#### **AIRPORTS AUTHORITY OF INDIA (AAI)**

##### **TRAFFIC TREND:**

Monthly Traffic Reporter for the month of September, 2022 has been prepared and uploaded on AAI website. The broad highlights of Traffic Reporter for the month of September, 2022 and (April–September) 2022-23 are as follows:-

**SEPTEMBER, 2022** - During the month of September, 2022, all Indian airports taken together handled 197.25 thousand aircraft movements (excluding General Aviation Movements), 24.94 million passengers and 273.34 thousand tonnes of freight.

**(APRIL– SEPTEMBER) 2022-23** - During the period of April – September 2022-23, all Indian airports taken together handled 1207.28 thousand aircraft movements (excluding General Aviation Movements), 150.04 million passengers and 1620.53 thousand tonne of freight.

**A. Airports Council International – Airport Service Quality (ACI-ASQ) Survey**

During October, 2022, ACI-ASQ survey at 13 AAI airports was conducted successfully.

**B. Customer Satisfaction Survey**

During October 2022, Customer Satisfaction Survey at 10 AAI airports was conducted successfully.

**C. Fleet Strength and On Time Performance-** Alliance Air has a fleet of 18 ATR 72-600 aircraft, 02 ATR 42-600 and 01 Dornier 228 and on time performance of 83% in October, 2022.

### **COMMISSION OF RAILWAY SAFETY (CRS)**

- A. 12 statutory inspections of Network Expansion related work of Doubling / Multiple Lines / New Lines / Gauge Conversion for a length of 244.36 kms were done by the Commissioners and authorizations issued, thus making the cumulative total of these works during the year 2022-23 to 1691.07 kms.
