

**Minutes of the 155<sup>th</sup> Meeting of the Empowered Committee constituted for examining proposals of Air Transport Services/ Import of Aircraft held at 11.00 A.M. on 22.11.2011.**

**The following proposals were considered by the Committee: -**

1. **M/s ABC Aviation and Training Services Pvt. Ltd: Grant of initial NOC to operate Scheduled Air Transport Regional Services in Southern Region.**

The Committee **recommended** the proposal.
