
Subject: Submission of Immovable Property Returns by Group A Officers for the year 2010 (as on 01.01.2011) - placing the same in public domain reg.

Madam / Sir,

I am directed to forward a copy of circular OM No. 11013/3/2011-Estt.A-IV dated 11th April, 2011 issued by DOPT on the subject mentioned above. It has been stated in the circular that the immovable property returns submitted by members of all Group A services of the Central Government for the year 2010 (as on 01.01.2011) will be placed in public domain by the respective cadre controlling authorities by 31-05-2011. In this connection, the Department of Personnel & Training have also enclosed a copy of circular issued by Establishment Officer (F.No. 11/7/2011-EO(PR) dated 04-04-2011). The circular issued by Establishment Officer clearly states that "Officers who do not submit the property return in time would be denied Vigilance Clearance and will not be considered for promotion and empanelment for senior level posts in Government of India.

2. It is requested that the above circular may please be brought to the notice of all concerned and Annual Property Returns of all Board Members in your Organisation including its chairman may please be sent to this Ministry latest by 31-05-2011.
