



Detailed Monthly information for the month of April, 2023

Important Policy decisions taken and major achievements during the month:

MINISTRY OF CIVIL AVIATION

1. Ministry of Civil Aviation successfully convened the European Union – India Aviation Summit at New Delhi on 20 - 21 April, 2023. During the Summit, a Declaration of Intent was signed between Airports Authority of India and Euro control for cooperation in the field of Air Traffic Management, and a Letter of Intent was signed by DGCA with the European Union Aviation Safety (EASA) for closer cooperation in area of Unmanned Aircraft System (UAS).
2. Hon'ble Prime Minister inaugurated New Integrated Terminal Building at Chennai Airport on 08.04.2023.
3. The Aircraft (Demolition of Obstructions caused by Buildings and Trees) Rules, 1994 were amended and published in the Gazette vide Notification No. GSR 291 (E) dated 13.04.2023.
4. This Ministry granted permission for operation of charter flights from Afghanistan, Mongolia and Turkey under special circumstances.
5. Five hundred and eighty five drones were registered and Unique Identification Number (UIN) were issued.
6. Four hundred and eighty six Remote Pilot certificates were issued.
7. One new Remote Pilot Training Organisation (RPTO) commenced.
8. Government of India granted 'Site Clearance' to Kerala State Industrial Development Corporation (KSIDC) for development of Greenfield airport at Kottayam, Kerala.
