

## Detailed Monthly information for the month of June, 2023

Important Policy decisions taken and major achievements during the month:

### MINISTRY OF CIVIL AVIATION

1. AAICLAS has commenced Domestic Air Cargo operations with Regulated Agent (RA) at Guwahati Airport on 27.06.2023.
2. AAICLAS has commissioned Air Cargo movement through Airline Self-Handling by M/s Indigo for Outbound Air Cargo Operations at Coimbatore airport on 02.06.2023 & Ranchi airport on 26.06.2023.
3. The Ministry granted permission for operation of charter flights from Afghanistan, Saudi Arabia, Mongolia, Malaysia and Kyrgyzstan under special circumstances.
4. Five hundred and sixty two drones were registered and Unique Identification Number (UIN) were issued.
5. Four hundred and fourteen Remote Pilot certificates were issued.
6. Three new Remote Pilot Training Organisations (RPTO) commenced.
7. One helicopter FTO was commissioned.
8. Two new RCS routes commenced.
