## MINISTRY OF CIVIL AVIATION

- 1. Passengers carried by domestic airlines continued to grow and was 923.35 lakh during January-July 2024 as against 881.94 lakh during the corresponding period of the previous year, thereby registering annual growth of 4.70%.
- 2. Commencement of new RCS airports/heliports and routes
  - a. Airports operationalized 01, (Moradabad).
  - b. Routes Commenced 04 (Pune Sindhudurg) & (Moradabad Lucknow)
- 3. Bharatiya Vayuyan Vidheyak (BVV), 2024 was passed in Lok Sabha. This Bill which will replace the Aircraft Bill, 1934 provides for design, manufacture and maintenance of aircraft and streamline provisions relating to DGCA, BCAS, RTR etc.
- 4. Hon'ble Minister of Civil Aviation launched the new Guidelines for Seaplane Operations under the "Regional Connectivity Scheme (RCS)-UDAN" on 22nd August, 2024 with an aim to realise the potential of seaplane enhancing connectivity across India's long coastline and extensive network of rivers and lakes.
- 5. Union Cabinet approved development of new civil enclave at Bagdogra Airport, West Bengal at an estimated cost of Rs 1549 Crore and new civil enclave at Bihta, Bihar at an estimated cost of Rs 1413 Crore.
- 6. MoCA granted permission for operation of charter flights from Afghanistan under special circumstances during the month of August, 2024.
- 7. Promotion of drones was continued with following achievements:
  - a) 682 Unique Identification Number (UIN) for drones were issued in the month of August 2024.
  - b) 614 Remote Pilot Certificates (RPC) were issued in the month of August 2024.
  - c) 04 new Type Certificate for drones were issued during the month of August 2024.
  - d) 05 new Remote Pilot Training Organisation were certified by DGCA during the month of August 2024.
