- (v) Chennai International Airport received the Tamil Nadu Tourism Award- 2016 in the category of 'Best Tourist Friendly Airport'. This award is conferred by Madura Welcome, a tourist guide book company, in association with Incredible India, Ministry of Tourism and Government of India.

#### ii) SAP-ERP:

Enterprise Resource Planning application implemented and has been rolled out across India, handling all employee and third party related payments, MIS, Project, Planning

#### iii) SAP-SRM:

Supplier Relations Management Software, used for hosting tenders and auctions. At present this application is being migrated to CPPP hosted in NIC. Hosted in AAI's data center and CPPP is hosted in NIC.

#### iv) <u>SAP-ESS</u>:

Employee Self Service – A part of ERP application used by the employees for day-to-day activities like leave management, all other employee related payments, Performance monitoring, etc. Hosted in AAI's data center.

#### v) NOCAS:

NO Objection Certificate Application System – used by public for obtaining NOC for the purpose of building buildings and structures near to the airport. At present NOCAS-II is running and hosted in BSNL cloud.

#### vi) AIMS:

Airport Information Management System – used mainly for Air traffic and commercial. It has many other modules for day-to-day airport activities like issue of temporary pass, Inventory, Airport driving permit, etc.

#### vii) EPS:

Employee Pension Software – for handling PF contributions and related MIS. Hosted in AAI's data center.

#### viii) EPOS:

For the purpose of ensuring stopping revenue leakage from duty free shops in airport terminals. Hosted in AAI's data center.

#### ix) Grievance KIOSK in Airports:

For the passengers to use Airsewa application to register complaints, flight schedule and other airport related information. Hosted in AAI's data center.

#### x) Website:

AAI's Public website for displaying information about airports, tenders, contacts and local information. Hosted in AAI's data center.

## xi) Frequency Management System:

Used to allocate various frequencies being used by the Air Traffic controllers across the country for different purpose. Hosted in AAI's data center.

## xii) SCORE Application:

Package used to allocate time slots for airlines to operate aircrafts by considering different parameters like facilities, capacity, immigration, customs, etc. Hosted in AAI's data center.

#### xiii) Mail Application:

Used by all AAI employees for correspondence, hosted in AAI's data center.

#### xiv) AOCC:

Airport Operations Coordination Center – a repository of data from different sources, collected and disseminated centrally and used to take informed decisions for allocation of resources for airline operations. Hosted in Chennai with backup in Kolkata.
