# GOVERNMENT OF INDIA MINISTRY OF CIVIL AVIATION MONTHLY SUMMARY FOR THE MONTH OF JULY, 2015

1. Important Policy decisions taken and major achievements during the month:

Passenger carried by domestic airlines during January-June, 2015 were <u>388.33 lakhs</u> as against <u>324.11 lakhs</u> during the corresponding period of previous year thereby registering a growth of 19.81%. Ministry.

## (i) Airports Authority of India (AAI) :-

- The Airports Authority of India (AAI) has earned a profit of **Rs.115.17 crores** after deduction of tax during the month of **July**, **2015**.
- Pawan Hans Limited has earned a net profit of Rs.4.00 crores during the month of July, 2015.
- GAGAN systems certified for Approach with Vertical Guidance (APV) on 21<sup>st</sup> April, 2015 was formerly launched by Hon'ble Minister of Civil Aviation on 13<sup>th</sup> July, 2015 at New Delhi in the presence of Secretary MoCA, Scientific Secretary ISRO, DGCA and Chairman AAI.
- Training of Stakeholders for Flexible Use of Airspace was conducted at Delhi, Kolkata, Mumbai and Chennai.
- ATC Surveillance Minimum altitude Chart Mangalore Airport (VOML) and Coimbatore Airport (VOCB) Published.
- AIP supplement on "ESTABLISHMENT OF DOMESTICE ATS ROUTE J2 and J3 CONDITIONAL ROUTE (CDR 2)" has been promulgated with effect from 17<sup>th</sup> September, 2015.

## (ii) Air India Ltd.

#### Implementation of iCheck at London

The cutover to Icheck application on the kiosks and the new process of self bag tag and scan went off successfully at London T4 terminal as scheduled. The flight AI-112 of July, 27, 2015 from London to Delhi was the flight chosen for the new process implementation. The whole process of implementation started on July 20, 2015 when testing of the new application and self bag drop process at the ARINC lab HAL model terminal went off successfully and due certification and go-ahead for the implementation was obtained from HAL

#### **Green Initiative:**

For solar Power Plant of 50 KWP capacity at Air India Unity Complex, Chennai, Party was finalized after formal process and LOI issued on July 24,2015 to M/s Energy System Limited, Chennai.

### (v) Ministry (Main):

**E-Office -** Implementation of 'e-Office', a digital filing system was started in the Ministry in October, 2014 and is fully operational now. The system was officially launched on 25.12.2014 by the Hon'ble Minister for Civil Aviation, as a Good Governance initiative. All new files are being generated through 'e-Office. Apart from the Ministry, all subordinate organizations such as DGCA, Air India, Airport Authority of India, Commission of Railway Safety, and Pawan Hans Ltd. are also implementing 'e-office. The digitized filling system reduces the processing time substantially and ensures transparency and accountability, as any file can be located and dealt with within a few minutes. The service records of the officers and staff are also being digitized, to speed up processing of all personnel claims. The process or E-Service Book in respect of all Officers/Officials in Ministry (Main) has also been done. The Officers/Officials will be able to view their details and apply on-line for grant of leave etc.

# (vi) Commission of Railway Safety (CRS):-

- During the month of <u>July, 2015</u>, one statutory enquiry has been taken up by Commission of Railway Safety:
- Hitting of Passenger with clamp set of Signal No.S-38 of train No.31621 UP EMU local at Level Crossing Gate No.11/T of Titagarh Station of Sealadah Division of Eastern Railway on 14.07.2015. As a result of this accident, 02 passengers were grievously injured and 08 passengers got simple injuries – CRS, Eastern Circle.
  - (i) Statutory inspections were conducted before opening of **Eight (08)** lines for public carriage of passengers.
  - (ii) During the month of **July, 2015**, there were **Nine (09)** Periodical or other Inspections of Railway made by the Commission of Railway Safety.]
