(iii) Civil Aviation Policy 2016

The National Civil Aviation Policy 2016 released recently aims to take flying to the masses by making it affordable and convenient, establish an integrated ecosystem which will lead to significant growth of the civil aviation sector to promote tourism, employment and balanced regional growth, enhance regional connectivity through fiscal support and infrastructure development and enhance ease of doing business through deregulation, simplified procedures and e-governance. It covers 22 areas of the Civil Aviation sector.

(iv) Passengers carried by domestic airlines during January-June, 2016 were <u>475.79 lakhs</u> as against <u>388.33 lakhs</u> during the corresponding period of previous year thereby registering a growth of <u>22.52%</u>.
