(i) Civil Aviation Policy 2016

The National Civil Aviation Policy 2016 released recently aims to take flying to the masses by making it affordable and convenient, establish an integrated ecosystem which will lead to significant growth of the civil aviation sector to promote tourism, employment and balanced regional growth, enhance regional connectivity through fiscal support and infrastructure development and enhance ease of doing business through deregulation, simplified procedures and e-governance. It covers 22 areas of the Civil Aviation sector.

(ii) Passengers carried by domestic airlines during January-May, 2016 were <u>396.04 lakhs</u> as against <u>322.32 lakhs</u> during the corresponding period of previous year thereby registering a growth of 22.87%.

Air India Charters Ltd.

Following additional flights commenced operations effective June 2016.

- Kozhikode Dubai Kozhikode The frequency of flights between Kozhikode and Dubai has been increased from daily to twice daily. Thus the frequency has increased from 7 to 14 flights/week.
- Kozhikode Kuwait Kozhikode The frequency has been increased to operate from 3 to 5 flights / weeks including the thrice weekly connection between Mangalore and Kuwait, Air India Express now has daily connections to Kuwait from South India.

- Kochi Kozhikode Bahrain and Kozhikode Doha Kozhikode The services on the Kochi / Kozhikode / Bahrain / Doha/ Kozhikode / Kochi route has been restructured to operate a daily flight on Kochi Kozhikode Bahrain vv and a daily non-stop flight between Kozhikode and Doha. - Pre-booked meal service has been launched online to the passengers on select sectors. This facility shall be extended to other sectors on the network, in due course.
- During the first quarter of FY 2016, Air India Express has increased its operating revenue by 12.6% against a capacity increase of 15%. In June 2016, the increase in operating revenue has been to the tune of 21%.
