Detailed Monthly information for the month of October, 2021

Important Policy decisions taken and major achievements during the month:

1. MINISTRY OF CIVIL AVIATION

- A. Commencement of new RCS Airports and routes: 02 new RCS airports and 20 new RCS routes have been commenced in the month of October, 2021.
- B. Air Cargo related activities -

In October, 2021, AAICLAS has handled vaccine cargo consignments containing more than 12.91 crores vaccine doses through 32 AAICLAS Air Cargo terminals in the Domestic & International Sector.

- C. Two Greenfield airports, namely, Sindhudurg and Kushinagar have been operationalised on 09.10.2021 and 20.10.2021 respectively.
- D. Three AAI airports namely, Guwahati, Jaipur and Thiruvananthapuram awarded for Operation, Management and Development under PPP have been handed over to the Concessionaire i.e. M/s Adani Enterprises Ltd. On 08.10.2021, 11.10.2021 and 14.10.2021 respectively.
- E. After review of the current status of scheduled domestic operations viz-a-viz passenger demand for air travel, this Ministry vide Order No. 27/2021 dated 12.10.2021 decided to restore the scheduled domestic air operations with effect from 18.10.2021 without any capacity restrictions.
- F. National Unmanned Aircraft System Traffic Management (UTM) Policy Framework was released on 24.10.2021.
- G. 743 Drone Acknowledgement Numbers (DAN) have been issued in the month of October, 2021.
- **H.** Drone outreach program conducted in Dehradun and Kanpur on 08.10.2021 and 27.10.2021 respectively.
- I. PASSENGER GROWTH: Passengers carried by domestic airlines during January-September, 2021 were 531.11 lakhs as against 440.60 lakhs during the corresponding period of previous year thereby registering annual growth of 20.54% and monthly growth of 79.23%.

During the period of April – September 2021-22, all Indian airports taken together handled 699.82 thousand aircraft movements (excluding General Aviation Movements), 63.66 million passengers and 1536.86 thousand tonnes of freight.
