Important Policy decisions taken and major achievements during the month:

1. MINISTRY OF CIVIL AVIATION

A. After review of the current status of Scheduled domestic operations viz-a-viz passenger demand for air travel, this Ministry vide order No. 15/2021 dated 19.03.2021 has extended the opening of the sector in a calibrated manner till 30.04.2021 or until further orders.

Further, this Ministry vide order No. 16/2021 dated 19.03.2021 has increased the lower band of fares on all sectors by 5%.

- **B.** The Unmanned Aircraft Rules 2021 have been published in the Gazette as Notification no. AV-11012/4/2019-DG vide GSR No. 174 (E) dated 12.03.2021. Further, these Rules have also been laid on the Table of Rajya Sabha on 24.03.2021 and on the Table of Lok Sabha on 25.03.2021.
- C. Aircraft (investigation of Accidents and Incident) Amendment Rules 2021 have been published in the Gazette as Notification no. AV-11012/3/2019-DG vide GSR no. 222 (E) dated 30.03.2021.
- D. PASSENGER GROWTH: Passengers carried by domestic airlines during Jan-Feb 2021 were 155.61 lakhs as against 251.50 lakhs during the corresponding period of previous year thereby registering annual growth of -38.13 % and monthly growth of -36.71 %.
- **E.** 30 new RCS routes have been commenced and operations started from 03 new airports in the month of March, 2021.
- F. Government of India, in exercise of the powers conferred under Rule 160 of the Aircraft Rules, 1937, has granted conditional exemption from the provisions of the Rule 15A to Indian Institute of Sugarcane Research (IISR), Lucknow for conducting drone spraying to control pests and diseases of sugarcane crop.
- **G.** Government of India, in exercise of the powers conferred under Rule 70 of UAS Rules, 2021, has granted conditional exemption to the following entities:
 - a. Adani Defence Systems and Technologies Limited (ADSTL) for demonstration of counter-drone system to Government organisations using drones.
 - b. Professor Jayashankar Telangana State Agricultural University (PJTSAU) for agricultural research activities using drones.
- **H.** 34 green zone sites for No-Permission-No-Takeoff (NPNT) compliant drones were approved on 24 March 2021.

I. 453 Drone Acknowledgement Numbers (DAN) issued in the month of March, 2021.

J. Krishi Udaan – Airlifting agri-produce for better value realisation for farmers:

i. Total tonnage of agri-perishables handled in the 12th month of FY 2020-21 ending on 31 March, 2021 was 18,962 MT.

2. DIRECTOR GENERAL OF CIVIL AVIATION (DGCA)

A. The following Regulations (CARs) in important areas have been issued/revised by DGCA during the month of March, 2021:

I. Revision to CAR Section 7 Series I Part I:

- a) There was long term demand from ATO industry to introduce the SFE concept in India. This gives AOs feasibility to complete Type ratings without being dependent on the industry DEs.
- b) It was essential to align the existing CAR Section 7 Series I Part 1 to include the additional requirements for delegating DGCA checking authority to personnel other than delegated Examiners/ FOIs of the DGCA for ATOs.
- **c)** It gives chance to Industry to utilize the trainers, who are available and seeking job opportunities in India and can contribute to the Industry through their wide and vivid experience since prevailing job retrenchments in aviation sector.
- **d)** Indian Pilots are so far being granted type ratings by DGCA by undergoing such endorsement training, if carried out by an ATO of contracting State or by ATO in India under concurrent approval of contracting State.
- e) The same is included in line with EASA and as per provisions of ICAO Annex 1, while maintaining the eligibility with some additional conditions.
- **II. Revision to CAR Section 7 Series J Part IV :** CAR Section 7 Series J Part IV, issue I, Rev 0 is being issued due to the following reasons:
 - a) FDTL CAR, Section 7 Series J Part III was taken up for revision in year 2018 following a Delhi HC order. This CAR applied uniformly to all flight crew whether engaged in scheduled, nonscheduled or general aviation operations.
 - **b)** At the time of revision, a decision was taken to address the requirements of operators other than scheduled operators in a separate FDTL CAR, which is 'Section 7 Series J Part IV'.
 - c) The Draft CAR has now been revised based on the comments. Also, a fresh provision of FDTL limits for single pilot operations has been included in the revised draft CAR which necessitates placing the CAR on DGCA website for public comments once again.
 - d) In the backdrop of the above-listed concerns, as well as to provide appropriate and effective regulations governing the flight duty time and rest time requirement for the non-scheduled, scheduled commuter and general aviation including Govt. operators also, a new issue of CAR Section 7 Series J Part IV issue 1 Rev. 0 has been developed.
- **B.** Exemption granted from the relevant Paragraphs of CAR Section 3, Series X, Part-I to IOT Sporting Aspirations Pvt. Ltd. for conducting an activation within the stadiums during the ongoing India Super League (ISL) using Remotely Piloted Aircraft Systems (RPAS).

4. <u>AIRPORTS AUTHORITY OF INDIA (AAI)</u>

TRAFFIC TREND:

Monthly Traffic Reporter for the month of February, 2021 has been prepared and uploaded on AAI website. The broad highlights of Traffic Reporter for the month of February, 2021 and (April– February) 2020-21 are as follows: -

FEBRUARY, 2021

During the month of February, 2021, all Indian airports taken together handled 151.35 thousand aircraft movements (excluding General Aviation Movements), 16.87 million passengers and 244.97 thousand tonnes of freight.

(APRIL-FEBRUARY) 2020-21

During the period of April – February 2020-21, all Indian airports taken together handled 1028.23 thousands of aircrafts movements (excluding General Aviation Movements), 98.43 million passengers and 2191.51 thousand tonnes of freight.

A. The DigitalSky platform Phase-1 has been launched on 18th March 2021: Digital Sky project is aimed to develop an IT platform to enable the Drone ecosystem in India as per DGCA CAR 1.0. The project is driven by MoCA through DGCA and AAI being the nodal agency for project execution. Digital Sky platform brings different stakeholders of Drone ecosystem on the same platform. It provides features for the registration of various public users like Manufacturers, Operators, Drones and government agencies like DGCA, AAI etc. Public users can apply for various permissions ex. Unique Identification Number (UIN) for drone, Unmanned Aircraft Operator Permit (UAOP), flight permission request etc. Government agencies process the various user requests as per the defined workflow. A set of airspaces where drone operations are permitted (called as green zones) have been mapped on to the DigitalSky platform and users with required licenses can submit flight plans for seeking permission to fly. DigitalSky platform processes the submitted flight plans as per a workflow and permission artifact for a particular flight plan issued after the approval.
