

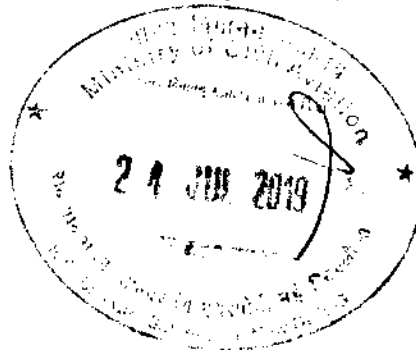

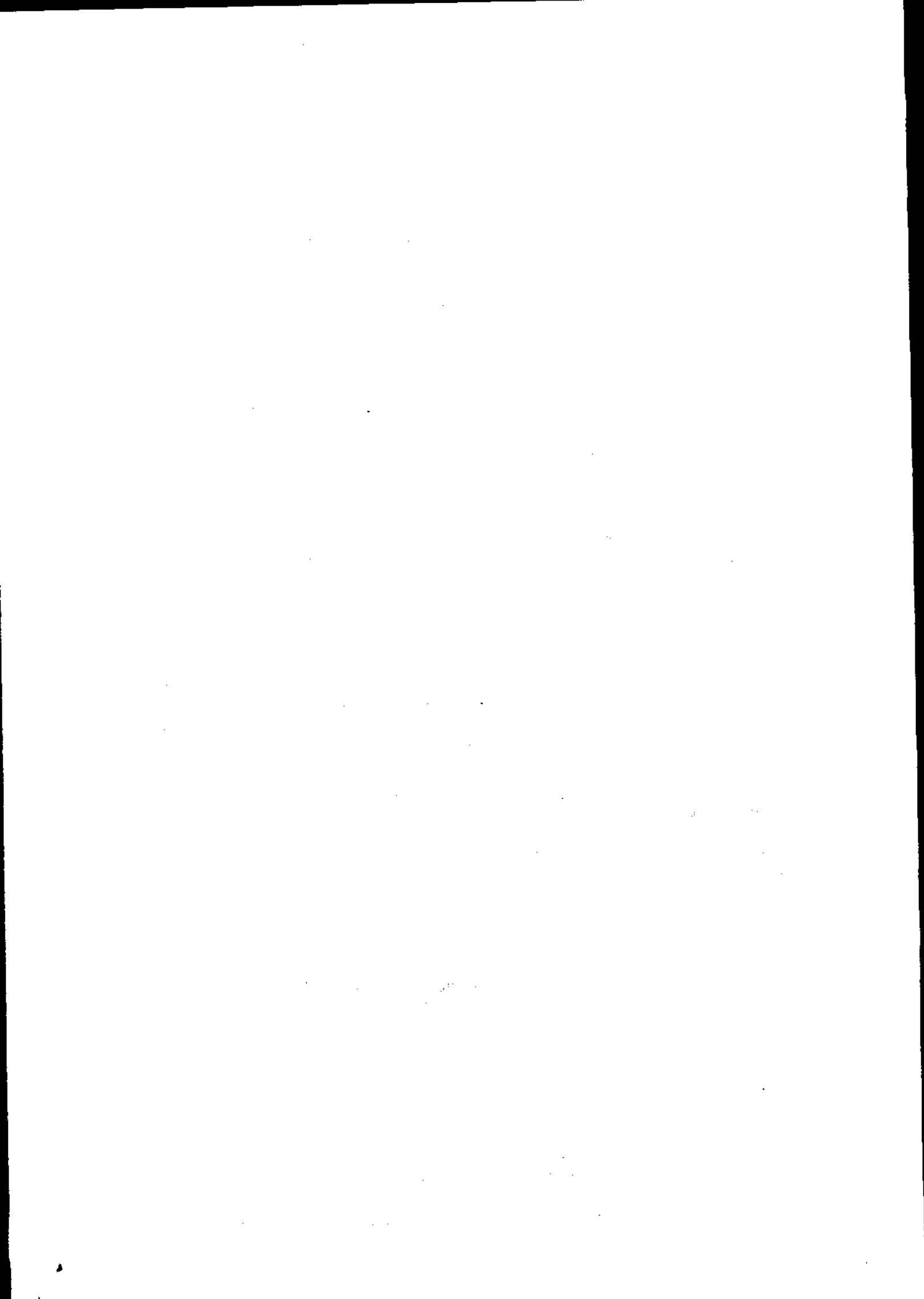

Detailed Monthly information for the month of June, 2019

Important Policy decisions taken and major achievements during the month:

1. Ministry of Civil Aviation

A. Passengers carried by domestic airlines during Jan-May, 2019 were **586.54 lakhs** as against **571.58 lakhs** during the corresponding period of previous year thereby registering a growth of **2.62%**.

4. Airports Authority of India (AAI)

- A. The Airports Authority of India (AAI) has earned a profit of Rs.189.25 crores after deduction of tax during the month of June, 2019.
- B. Civil Aviation Minister Shri. Hardeep Singh Puri inaugurated the state-of-the-art Central Air Traffic Flow Management system (C-ATFM) in Vasant Kunj, New Delhi on Saturday 22nd June 2019 for helping to deliver optimum air traffic to airports with least average delay, this planning tool enables improved management of demand and capacity.
- C. Development of New Civil Enclave completed at Allahabad Airport – Design & Build at a cost of Rs. 137.52 crores on 17.05.2019.
- D. Interior work on first floor of terminal building at SGRDJ International Airport, Amritsar completed at a cost of Rs. 10.98 Crs. i/c GST on 15.06.2019
- E. Work awarded for:
- (i) Development of New Civil Enclave at Bareilly. SH: Construction of Pre-Engineered Terminal Building and Associated Works-Design & Build Basis at a cost of 35.56 crores (Excluding GST) on 03.06.2019
- (ii) Construction of staff quarters at Coimbatore International Airport & Construction of new Residential Staff Quarters, CISF Barracks, Dog kennel & Community hall at old wireless station at Trichy Airport at a cost of Rs. 104.15 crores on 25.06.2019.
- F. ASM Directorate, AAI organized a training on "Operationalization of Delhi Airspace Management Cell (AMC)" at CATFM Facility in Vasant Kunj, New Delhi from 10th to 14th June 2019. Representatives from IAF, Indian Navy, DGCA, Airline Operators and AAI (ATFM and ASM) attended the training programme.

G. TRAFFIC TREND:

MAY, 2019 VIS-À-VIS MAY, 2018

During the month of May 2019, all Indian airports taken together handled 212.94 thousand aircraft movements (excluding General Aviation Movements), 28.91 million passengers and 293.41 thousand tonnes of freight. The aircraft movements, passenger and freight traffic have decreased by 2.7%, 0.7% and 4.0% respectively during May 2019 over May 2018.

(APRIL- MAY) 2019-20 VIS-À-VIS (APRIL- MAY) 2018-19

During the period of (April-May) 2019-20, all Indian airports taken together handled 414.10 thousands of aircrafts movements (excluding General Aviation Movements), 55.61million passengers and 568.57 thousand tonnes of freight. The aircraft movements, passenger and freight traffic have decreased by 3.0%, 3.0% and 3.6% respectively during the period under study.
