Monthly Traffic Reporter for the month of August, 2019 has been prepared and uploaded on AAI website. The broad highlights of Traffic Reporter for the month of August, 2019 and (April- August) 2019-20 are as follows: -

AUGUST, 2019 VIS-À-VIS AUGUST, 2018

During the month of August 2019, all Indian airports taken together handled 217.12 thousand aircraft movements (excluding General Aviation Movements), 28.78 million passengers and 288.53 thousand tonnes of freight. The aircraft movements and passengers have increased by 0.4% and 2.8% respectively while the freight has decreased by -5.3% during August 2019 over August 2018.

(APRIL- AUGUST) 2019-20 VIS-À-VIS (APRIL- AUGUST) 2018-19

During the period of (April-August) 2019-20, all Indian airports taken together handled 1058.18 thousands of aircrafts movements (excluding General Aviation Movements), 142.27 million passengers and 1423.74 thousand tonnes of freight. The aircraft movements and freight traffic have decreased by -1.2% and -4.7% while passengers have increased by 0.4% respectively during the period under study.
