GOVERNMENT OF INDIA MINISTRY OF CIVIL AVIATION MONTHLY SUMMARY FOR THE MONTH OF FEBRUARY, 2016

1. Important Policy decisions taken and major achievements during the month:

Passengers carried by domestic airlines during January, 2016 were <u>76.55</u> <u>lakhs</u> as against <u>62.45 lakhs</u> during the corresponding period of previous year thereby registering a growth of 22.58%.

INDIA-FIJI MOU

The delegations representing the Government of Republic of India and the Government of the Republic of Fiji met in New Delhi on 4th February, 2016 and a MOU was signed on the following matters:-

Air Service Agreement

Two delegations finalized and initialed the text of a revised Air Service Agreement (ASA) to be signed between the two countries. It was agreed that necessary internal procedures would be completed by both the Governments.

Capacity Entitlements

It has been agreed that the designated airlines of each side shall be entitled to operate up to a total of Three (3) frequencies per week in each direction.

As a result of this accident, 01 Railway Crew (Loco Pilot) was grievously injured and 01 Railway Crew (Assistant Loco Pilot) got simple injury – Inquiry by CRS, Western Circle, Mumbai.
