A meeting of the Empowered Committee was held at 11:30 AM on 30.5.2012, wherein issues relating to 'Owner-Operator' came up for discussion. Subsequent Empowered Committee meeting was held on 20.6.2012, wherein it was informed that with the approval of HMCA it has been decided that the initial NOC issued by the Ministry should highlight the names of the Operator, lessor, lessee, financer, Hypothecator and place of parking as per information provided by

the applicant himself. Suitable amendments to the CAR proforma have also been proposed.

In accordance with the decision, and till such time the CAR Proforma is modified, it was decided that information, as furnished by applicant, regarding name of operator, owner, financer, lessor, `1lessee, place of parking be stated in the minutes of the Empowered Committee meeting and in the initial NOC.

Accordingly the following proposals were considered by the Committee: -
