Important Policy decisions taken and major achievements during the month:

MINISTRY OF CIVIL AVIATION

- 1. Approval of the Cabinet was obtained for naming of Hollongi airport as Donyi Polo Airport, Itanagar, the first Greenfield Airport of Arunachal Pradesh. The airport was inaugurated on 19.11.2022 and is operational since 28.11.2022.
- 2. 128 Conditional Routes established under Flexible Use of Airspace Policy by AAI in co-ordination with IAF till the month of November, 2022.
- 3. M/s Velocity Aviation IFSC Pvt. Ltd. has registered with International Financial Services Centers Authority (IFSCA) on 09.11.2022 for Aircraft Operating Lease. As on 30.11.2022, Twelve (12) Aircraft leasing entities have been registered with IFSCA.
- 4. Passengers carried by domestic airlines during Jan-October, 2022 were 988.31 lakhs as against 620.96 lakhs during the corresponding period of previous year thereby registering annual growth of 59.16% and monthly growth of 26.95%.

- 5. 04 new RCS routes commenced in the month of November, 2022.
- 6. 1032 Drones were registered and Unique Identification Number (UIN) were issued for them in the month of November, 2022.
- 7. 451 Remote Pilot certificates were issued in the month of November, 2022.
