Detailed Monthly information for the month of August, 2022

Important Policy decisions taken and major achievements during the month:

MINISTRY OF CIVIL AVIATION

- 1. MoCA facilitated the air transport of pilgrims for Haj 2022 operations which commenced from 4th June, 2022 and have completed on 13th August, 2022. This year, three airlines i.e Saudi Arabian Airlines, Spicejet and Flynas carried 56634 pilgrims from 10 embarkation points across India to Jeddah/ Madinah and back. All the participating airlines have carried out entire Haj Operations with meticulous planning and professional zeal.
- 2. Recruitment Rules for the post of DG, Directorate General of Civil Aviation (DGCA) have been published vide notification dated 25.08.2022.
- 3. 416 additional posts in DGCA have been created vide Order dated 24.08.2022 for restructuring of DGCA.
- 4. AAI Cargo Logistics and Allied Services Company Limited (AAICLAS), Kolkata received Regulated Agent (RA) 3 approval from European Union on 10.08.2022.
- 5. As on 31.08.2022, ten (10) Aircraft leasing entities have been registered with International Financial Services Centers Authority (IFSCA).
- On 10.08.2022, Principal Commissioner of Customs, Chennai Air Cargo inaugurated newly AAICLAS created Customs offices which would revamp Export Cargo flow pattern and advance the handling processes.
- 7. Passengers carried by domestic airlines during Jan-July 2022 were 669.54 lakhs as against 393.44 lakhs during the corresponding period of previous year thereby registering annual growth of 70.18% and monthly growth of 93.82%.
- 8. 02 airports and 08 new RCS routes commenced in the month of August, 2022.
- Long grounded Airbus aircraft VT-PPI was made serviceable after carrying out 12 year inspection checks and other maintenance activities on 24.08.2022. The aircraft was grounded since 17.04.2020.
- 10. 215 Drones were registered and Unique Identification Number (UIN) were issued for them in the month of August, 2022.

- 11. 173 Remote Pilot certificates were issued in the month of August, 2022.
- 12. The Ministry of Civil Aviation conducted "Mission Karmayogi-Immersive Training" programme for the second batch of its employees from 22nd to 26th August, 2022.

TRAFFIC TREND:

Monthly Traffic Reporter for the month of July, 2022 has been prepared and uploaded on AAI website. The broad highlights of Traffic Reporter for the month of July, 2022 and (April–July) 2022-23 are as follows:-

JULY, 2022 - During the month of July, 2022, all Indian airports taken together handled 196.29 thousand aircraft movements (excluding General Aviation Movements), 23.94 million passengers and 275.03 thousand tonnes of freight.

(APRIL- JULY) 2022-23 - During the period of April — July 2022-23, all Indian airports taken together handled 809.86 thousand aircraft movements (excluding General Aviation Movements), 100.42 million passengers and 1085.70 thousand tonne of freight.

A. Airports Council International – Airport Service Quality (ACI-ASQ) Survey

During August, 2022, ACI-ASQ survey at 13 AAI airports was conducted successfully.

B. Customer Satisfaction Survey

During August 2022, Customer Satisfaction Survey at 24 AAI airports and 1 Cargo Terminal was conducted successfully.

ALLIANCE AIR AVIATION LTD.
