# Detailed Monthly information for the month of March, 2018

Important Policy decisions taken and major achievements during the month:

#### 1. Ministry of Civil Aviation

- (i) Passengers carried by domestic airlines during February, 2018 were <u>229.09</u> <u>lakhs</u> as against <u>182.34 lakhs</u> during the corresponding period of previous year thereby registering a growth of <u>21.80%</u>.
- (ii) An important milestone in the disinvestment process of Air India was achieved by uploading Preliminary Information Memorandum on 28th March inviting Expression of Interest for potential bidders.
- (iii) Digital Air Cargo e-Contracting/ Booking Platforms: Ministry of Civil Aviation has conceptualized the development of a completely seamless digital air cargo supply chain, which also integrates the shippers and consignees, in all formats: C2B, B2B and G2B. One crucial component of this chain is the online booking or contracting of air cargo shipments (which presently are done manually by the freight forwarder soliciting airline routes, rates and schedules. Now, two digital pan-India e-Contracting/ Booking platforms, namely, (i) Cargo E-Go and (ii) Rigel Kale's E-Booking Platform which have been developed competitively by private enterprises with the active engagement of air cargo stakeholders (including airports, airlines and freight forwarders) for facilitation in getting optimal booking rates, routes, schedules and vendor choices etc. on a single digital platform. The two portals were launched with the support of MoCA at the inaugural session of Wings India 2018 on 8.3.2018 at Hyderabad. development marks the first-in-the-world end-to-end digital supply chain initiative.
- (iv) A tripartite understanding has been reached between the Ministry of Civil Aviation and the National Aviation University (NAU) of the Government of India on the one hand, and the International Air Transport Association (IATA) on the other, in order to expand the pool of civil aviation professionals and to extend the reach of affordable vocational training in various aviation disciplines to students throughout India through the following: (a) academic cooperation between NAU and IATA and cross recognition of their training programmes, (b) utilization of IATA's existing training infrastructure in India to increase the student intake in aviation streams, and (c) development of alliances with various public and private sector training institutions across India through specific incentives on training modules as well as ensuring of course delivery and assessments provided by IATA.

Al and TP implemented a free flow code share arrangement on the following sectors effective 15 March 2018 for the carriage of India/Portugal vv traffic.

#### 5. Commission of Railway Safety (CRS)

- (i) During the month of March 2018, 50 statutory inspections were done by the Commissioners which include long stretches of RE and Doubling. Total 1685 kms of RE and 261 kms of Doubling works were inspected during March 2018.
- (ii) Recent statutory inspection of Doubling on 5 block sections of 41 km in Alipurduar Division of NF Railway is the highest ever for doubling in a single stretch which includes New Coochbehar Junction, having traffic from 6 directions. So total 11 stations were handled simultaneously during Non-Interlocked working.
- (iii) During the month of March 2018, 50 statutory inspections were done by the Commissioners which includes long stretches of Railway Electrification (RE), Doubling/Multiple lines, New Lines (Network Expansion). Total 1685 kms of Railway Electrification (RE) and 261 kms of Doubling works were inspected during March 2018.
- (iv) 482 Kms of Periodical Inspections have been carried out by different CsRS.in the month of March 2018.
- (v) During March 2018, 605 Minor Works and 6 cases of Rolling Stocks (RS) have been sanctioned.
