5. Air India Ltd.

The financial performance of the company is steadily improving over the past few years. The details of the Operating Profit/(Loss) and Net Profit/(Loss) of the company for the period 2015-16 (Prov) vis-à-vis 2014-15 are given below:

Air India is expected to earn Operating Profit of Rs.105.01 crores as compared to the Operating Loss of Rs.2636.18 crores in the previous year. This is the first time that the Company is going to achieve Operating Profit since its merger in 2007-08. The Net Loss will also be reduced by 35% i.e. by Rs. 2023.14 crores. The Net Loss during 2015-16 is expected to be around Rs.3836.77crores as against Rs.5859.90 crores in 2014-15. EBIDTA will increase to Rs.2415.03 crores as against Rs.337.78 crores during 2014-15.

7. Pawan Hans Limited (PHL)

The Pawan Hans Limited (PHL) has earned a net profit of **Rs.0.61 crores** after deduction of tax during the month of **September**, **2016**.

Pawan Hans has commenced helicopter services for Shri Kedarnathji Yatra w.e.f. 12th September till 26th October, 2016 - ex-Phata-Kedarnath-Phata with the deployment of 01 AS350 B3 helicopter.

Pawan Hans has also launched helicopter services from 29 September to 16 October, 2016 during the festival 'Mysuru Dassara' at Mysore, organized by the Govt. of Karnataka for promoting heli-tourism.

Rohini Heliport

Design, drawing for construction & commissioning work have been approved. All statutory approvals have also been received. Construction of FATO and Apron/Parking Area have been completed 100% as on date. Construction of Civil Structure for PTB, ATC, Fire, and Utility Building completed 100% as on date and all finishing work is in advance stage. Heliport is scheduled to be operationalized in October, 2016.

A trial landing of B3 helicopter was done successfully on 16/02/2016. After that successful trial landing of MI-172 helicopter was done on 30/04/2016. The budget for additional funds towards revised cost of Project Rs.99.25 crores has been approved by

MoCA on 07.06.2016. Parliamentary Standing Committee conducted site visit / inspection on 17/06/2016 at Rohini Heliport Project. Statutory approval from DGCA Electrical Inspector, Delhi Fire Department, Environment Deptt., are applied and the same are under process for approval.

8. Commission of Railway Safety (CRS).

- (a) During the month of <u>September, 2016</u>, one statutory inquiry has been taken up by Commission of Railway Safety:
 - (i) Collision of Train No.78408 Dn Passenger dashed with Goods Train No.E/DKAE/BCN at Km. 410/12-14 on Dn line between Barang-Cuttack Stations of Kurda Road Division of East Coast Railway on 29.09.2016. As a result of this accident, 02 persons were killed, 04 were grievously injured and 13 got simple injuries.
- (b) Statutory inspections were conducted before opening of **<u>Eight (08)</u>** lines for public carriage of passengers.
- (c) During the month of **September, 2016**, there were **Eight (08)** Periodical or other Inspections of Railway made by the Commission of Railway Safety.
